Treasurers report of 29th November 2025

The fees generated by qualified skydivers in 2025 totalled £12956 compared to £18862 in 2024. This is yet another a significant annual decline.

Recommendations for 2026

The treasurer recommends that the fees for qualified jumpers for 2025 is increased to £29 per flight for any qualified skydiver completing 1 to 60 jumps between February and December of each year, reducing to the minimum £19 thereafter for 61+ flights over the same period.
